# 596 Minutes

The Chairman thanked all members standing down this summer for their contributions and service to the Forum (including Mrs Deborah Booth, Mrs Linda Wells, Councillors Newcombe and Randall-Johnson). In addition Mrs Helen Nicholls had not sought re-election and her long service and contribution to the Forum was recognised. The resignation of Mrs Carol Williams, Devon Association Governors (Secondary) was also noted.

# 598 <u>Matters Arising from the Last Meeting and Report back on Issues Raised with Cabinet</u>

### **DISCUSSION:**

## Cabinet Member Representation on the Devon Education Forum (DEF minute 586(c))

DAG expressed its disappointment at the division of educational responsibilities between 4 Cabinet members:- Councillor Davis, (Children, Health & Wellbeing remit), as well as Councillor Barker (Adult Social Care, Families & Post 16 remit – including Youth Service), Councillor Clatworthy (Resources remit – including school buildings) and Councillor Mumford (Economy, Enterprise & Employment – including skills).

This was to complement the revised county council structure and Councillor Davis reported she would continue as the lead member for the Forum, taking these responsibilities very seriously and was in liaison with other Cabinet colleagues when appropriate.

# 599 <u>Head of Capital Development & Waste Management's Update</u> - Capital Programme

## **DISCUSSION:**

The Forum considered the report of the Head of Capital & Waste Management (DEF/12/12) giving an update on the delivery of the approved capital programme - capital programme new build, capital programme maintenance and priority schools building programme (PSBP). Devon had been successful with 10 out of 13 bids and officers were actively following up the lack of information regarding the PSBP private finance arrangement and the prioritisation details expected from the Education Funding Agency in early June. The Cabinet member had also written to Lord Hill. The schools concerned were being kept informed of developments and had submitted bids with the caveat that once details (in particular revenue charges) were known either the schools or LA may withdraw. 1 school had had to go out to tender in view of urgent structural work needed. Any of the budget not spent would be reallocated and spent this year, or rolled forward but schools generally preferred to have this to spend now.

# 600 Head of Education & Learning's Update

### **DISCUSSION:**

# (a) NEETS (Not in Education, Employment or Training)

The 14-19 SLG representative updated members on NEETs across Devon as of 31 May 2012:-

Further data analysis allowed identification of the areas of greatest need with high concentration of young people who were NEET. Over 45 different postcode areas in Devon the top ten hotspots for NEET were targeted for greater intervention work.

The Forum also noted Careers SW Ltd Statistical Reports – Peninsula 16-18 Cohort Summary (District Council) – March 2012 as tabled. Councillor Randall-Johnson also advised members that she was the County Council elected representative on Careers SW.

## (b) Service Delivery Agreement (SDA) 2012/13

There was now a different approach moving away from 36 different SDAs towards commissioning based impact for young people. There was a need for a trading platform to secure services for schools and the Head of Education & Learning was keen for there to be transparency in the commissioning/delivery of the SDAs between the County Council and Babcock LDP and would publish details. The SDA figures required updating and revised figures would be forwarded to members as soon as possible. The newly appointed Educational Commissioning & Contract Performance Manager, Mr Richard Belcher, was introduced to the Forum.

## (c) Commissioning Model 2013/14

This was being developed for the future with a further update to the Forum in the autumn.

## (d) Ofsted Inspections (Maintained Schools)

Reports published for spring term 2012 inspections showed Devon's maintained schools were generally in a good position but it was hoped to increase the number of schools receiving an

outstanding judgement. 2 Devon schools (4%) were found to be inadequate and these were being supported by Devon's TISP (Targeted Intervention and Support programme). There was an encouraging outcome following the introduction of the new Ofsted Inspection Framework (January 2012) and a self improving school system meant that schools were continually working towards improvement. When there was a sufficient number of schools inspected under the new Ofsted framework, benchmarking against statistical neighbours would be carried out and reviewed on a regular basis. The associations were keen to encourage all schools in Devon (academies etc) to make information easily available to the LA to show a complete picture of Devon. The academy representatives would welcome the opportunity to work alongside Devon LA to evaluate inspections and feed back comments to Ofsted (including training of Ofsted inspectors).

## (e) Welfare Reform Bill

The impact of this flagship bill on children and families who would receive a universal but capped benefit and the implications for schools where families were struggling to adjust to the new system were noted.

### **DECISION:**

- (a) that revised Service Delivery Agreement 2012/13 figures be forwarded to members as soon as possible;
- (b) that a further commissioning update be made to the Forum in the autumn;

## 601 Finance Update

## **DISCUSSION:**

The Forum considered the joint report of the Head of Education & Learning and County Treasurer (DEF/12/07) on:-

School Funding Reform – Next Steps towards a fairer system;

Independent placements;

School balances control mechanisms (capping);

Dedicated Schools Grant 2011/12 Outturn.

The Forum also considered minutes of the Schools Finance Group (SFG) of 27 June 2012 relating to the above.

(a) The report outlined the key principles of School Funding Reform and the DfE published response to the School Funding Reform consultation on 27 June 2012. It also set out the principles to be applied to the Devon formula, which is predicated on targeting as much of the funding as possible through pupil led factors. Local consultation will commence on 04 September and close on 17 September 2012, with consultation events to be held across Devon. Special schools and Early Years providers will be consulted with separately, running alongside the main consultation. The special schools consultation will close one day later on 18 September 2012.

The Head of Education and Learning wrote to all schools and Academies on 09 July with an update on LA progress in implementing the reforms and inviting them to the consultation events. Phase Associations are working with schools to raise awareness, and DCC has set up a dedicated website for interested parties to access information relating to the funding arrangements from 2013/14:-

- (b) With regard to Independent placement costs, SFG continued to review trends and costs of out of county and independent placements and the increasing capacity pressures on maintained special school places.
- (c) With the relaxation of School balance control mechanisms (capping) and LAs no longer required to have a capping regime, SFG were in favour of adopting a less formal process, but the County Treasurer would contact schools with unusual balances. There would be a further report to SFG in September.
- (d) The DSG outturn was £19.8m surplus. As at 31 March 2012 school's carry forward balances total £15.425, compared to £14.843m at end 2010/11 (increase of £0.582m). However the brought forward balances of in year converter academies was £3,018m so the underlying increase was £3.6m. There were several reasons for the underspend on centrally retained budgets (paragraph 7.2 of the report), some of which is required to meet ongoing commitments in 2012/13. SFG would consider further the possible delegation of a proportion of the centrally retained surplus at its September meeting.

# (a) <u>Draft Schools Forums (England) Regulations 2012, DfE Consultation</u> (ending 11 July 2012)

# **DISCUSSION:**

The Forum considered the joint report of the Head of Education & Learning, County Solicitor and County Treasurer (DEF/12/08). The Department for Education (DfE) proposed changes to the existing regulations are set out in their letter 13 June 2012 requesting any comments by 11 July 2012. This was a review of Schools Forum legislation following the School Funding Reform: Next Steps towards a Fairer System (Section 1.6) referring to improved schools forum arrangements and the need for local decision-making to operate in a consistently fair and effective way and in consultation with schools and academies. This included voting and membership changes detailed in the report including the additional requirement of Pupil Referral Unit representation as a separate group among schools members. Should PRU(s) become academies in the future representation would be reviewed.

### **DECISION:**

- (a) that the proposed regulation changes as set out in DfE letter 13 June 2012 and draft Schools Forum (England) Regulations 2012 and report DEF/12/08 be noted and incorporated into DEF's terms of reference and constitution, including the addition of Pupil Referral Units as a separate group among schools members;

# (b) <u>Devon Education Forum and Standing Group Structure Task & Finish Group</u>

### **DISCUSSION:**

The Forum considered the need for change in the changing educational landscape to retain its strengths and maintaining an appropriate level of service whilst reducing costs.

- (B) the Schools and Academies Membership of DEF continue to be reviewed annually reflecting the broadly proportionate pupil numbers expected to be within each category wef 1.9.12:
- (C) the phase associations continue to put forward their nominations for membership in line with these proportions and to contact Academy Governing bodies to either approve the nomination(s) or put forward an alternative candidate as agreed by the Forum in May 2011.
- (D) further clarification be sought regarding the DfE proposals to confine the voting arrangements to allow only schools members and providers from the private, voluntary and independent sector to vote on the funding formula (subsequently clarified within draft Schools Forums (England) Regulations 2012, 13 June 2011);
- (E) DEF reduce its meetings from 5 (5 meetings and a seminar) to 4, to meet as follows:end September/early October
  January (prior to Cabinet budget)
  March/April
  end June/early July;
- (F) a members' protocol be drawn up alerting members to specific aspects of DEF's constitution, including:- members' interests, voting arrangements and the introduction of a voting card system, substitute members, restrictions on membership, communication within the groups represented;

- (G) any regular communication from the authority to schools draw attention to the schools forum website (containing forthcoming schools forum meetings, agenda and minutes) and the webcasting of DEF meetings be investigated (see decision (b)(i) below);
- (H) DEF's terms of reference and constitution be amended to reflect the above changes and requirements of School Funding Reform.
- (ii) that in respect of the structure of standing groups etc:-
- (A) School Finance Group continue in view of its specialist role in considering complex financial issues and members' specialist knowledge and expertise gained over time;
- (B) the proposed revised structure be agreed as set out in Annex B including the replacement of the School Organisation & Policy Forum and the Local Admissions Forum with a new broader School Organisation Capital and Admissions Group (see decisions (b)(ii) and (iii) below):
- (C) that the proposed standing groups consider their terms of reference and cycle of meetings (where appropriate) for recommendation to DEF;
- (b) that the Devon Education Forum further agrees:-
- (i) that future meetings of the Devon Education Forum be webcast;
- (ii) that other sub group membership reflect that of the Schools Finance Group:
- (iii) that the Forum for Learning & Achievement be dissolved and a separate task & finish group be convened for a specific purpose if required.

The Forum considered the report of the Devon Association of Governors (DEF/12/11) setting out the proposed 6 point plan enabling governors to keep in touch with business in their LLCs and understand how the money is being spent (through governor involvement, including ensuring governing bodies had feedback from LLCs, governor representation on LLCs, LLC newsletters) and strategic governor involvement (action plans, monitoring and evaluation).

# 604 <u>DfE Performance Table Changes & Targeted Intervention and Support</u> Programme (TISP) Review

### DISCUSSION:

The Forum considered the report of the Head of Education & Learning (DEF/12/09). "The importance of teaching" education white paper signalled the government's intention for a strong and continuing role for performance tables.

Devon was also committed to the development of a self-improving schools system. The TISP had undergone a review to enable it to act quickly and align it with the changing and more challenging accountability framework for schools and the DfE's and OfSTED's sharp focus on underperforming schools, who saw the best solution for underperforming schools as academy conversion under a sponsor.

Devon schools were supported through a range of strategies and providers and Devon was playing a full part in developing its own National Leaders in Education (NLEs). The regional association of NLEs could also require updating on some of the issues and how Devon was providing NLEs. It could also be helpful for further details on floor targets to be circulated to schools since some schools may be unclear about some of the requirements. Whilst Devon school Ofsted reports were encouraging focus should also be to do increase the number of schools obtaining outstanding inspection reports.

# 605 The Troubled Families Programme in Devon

## **DISCUSSION:**

The Forum received the report of the Head of Education & Learning (DEF/12/06). This programme was key in the government's approach to social justice and reducing public sector costs and intended to turn around the lives of 120,000 "Troubled Families" (estimated 1370 in Devon) by the end of this Coalition's term of office. The programme aligned itself with the DCC strategic plan including focusing on children who were not in school. The report also detailed the government's "payment by results" and summary of progress in Devon. The Devon District Councils were also committed to the programme to supporting District Council responsibilities.

# 606 Intimate Care – A Model Policy for Schools

Young people must have a say in their individual care wherever they were able.
