## 50 <u>Devon Education Performance 2013</u>

The Committee received the report of the Head of Education and Learning on the education performance at all Key Stages for Devon in 2013, the comparison of Devon s performance with similar authorities and national data and the priorities for improvement.

The Head of Service, in responding to matters raised or specific questions posed by Members stated:-

it was an improving picture but there were still areas where improvements could be achieved particularly with KS4, vulnerable groups and children in care

research was to be carried out into why there is drop in attainment between KS2 and KS4

virtual Schools practice were being reviewed

there needed to be a sharper focus on Personal Education Plans, placement stability, early intervention/support into schools, designated tutors/teachers

following the changes in Ofsted rules, schools that were classed as satisfactory last year were now described as requires improvement
