#### **Weed Treatment in Exeter**

Report of the Head of Highways, Capital Development and Waste

Please note that the following recommendation is subject to consideration and determination by the Committee before taking effect.

Recommendation: It is recommended that the Committee welcomes the progress with addressing weed growth in the City, within the available budgets.

#### 1. Introduction

A report was taken to the Exeter Board on 28 April 2014 to inform Members of the Weed Spraying Programme for 2014/15 in Exeter and the outcome of the Community Payback trial in 2013/14. This report updates members on the weed treatment programme and planned works for the remainder of this financial year and proposals for 2015/16.

## 2. Background

Cabinet approved the report of the Head of Highways, Capital Development and Waste to Cabinet on 12 March 2014 setting out the County Road Highway Maintenance Revenue Budget for the financial year 2014/15. The report included an allocation of £343,916, for the treatment of Weeds across the Devon. Of this, £37,923 was for Harmful & Invasive Weeds, £20,400 for the Community Payback Scheme and the remainder for targeted weed spraying across Devon.

Approximately £25,500 of the weed spraying budget was allocated to Exeter.

An order was placed with Exeter City Council at the start of the 2014/15 financial year once the DCC budget was agreed, to undertake weed spraying in the city in line with the treatment undertaken the previous year. The advice received from the City Council was that due to the delayed start of the 2014/15 spraying programme, it would not be cost effective to belatedly spray weeds because of the level of growth already sustained.

The advice was accepted and the budget was reallocated to undertake a programme of targeted weed spraying and pulling on strategic routes and key areas of the city. It also funded a mechanical sweeper to clear weeds from kerb edges. These works were in addition to the deployment of the Community Payback team as detailed below.

The allocation of a budget to fund Community Payback work followed a successful trial undertaken in the Exeter and Newton Abbot areas in 2013/14. The work proved to be very cost effective in terms of productivity and social value as reported to this committee on 27 January 2014.

The £20,400 allocated across Devon for the Community Payback scheme was to fund approximately 15-20 days of weed treatment work to be undertaken in Exeter. This commenced in mid November, concentrating on a list of known problem areas identified by Neighbourhood Highways Officers in liaison with local members.

On completion of the originally planned Community Payback days of weed treatment, due to the extent of weed growth at a number of locations, an extension to the programme was agreed utilising funding originally allocated for weed treatment elsewhere in the County. The outstanding programme was reviewed in light of comments from local Members and complaints from residents,

The Strategic Routes sprayed by the City Council during the autumn and subsequently cleaned by the Community Payback team are listed in Appendix I.

The original list, together with details of the sites attended to by the Community Payback team is included as Appendix II to this report.

#### 3. Future Arrangement for 2015

There is funding remaining in the County Council's 2014/15 revenue budget allocation for the treatment of weeds for further work in March 2015. In addition the Exeter Board at its meeting in September 2014 resolved that

"....the use of £20,000 from the Exeter Board's budget for early weed spraying in 2015 be supported"

With this combined funding the following programme of weed treatment is planned for 2015:

- a) the spraying of weeds growing in areas inaccessible to the Community Payback team during March. The areas are predominantly central reservations on sections of dual carriageway, focusing on Rydon Lane due to its proximity to Sandy Park and the imminent attraction of visitors to the Rugby World Cup in October.
- b) a weed spray of footways throughout the city during March.
- c) an additional spray of footways where needed and subject to the availability of funding, during June and July.

#### 4. Financial Considerations

The cost of this work will be met from the County Council's Revenue Budget and, pending confirmation, the Exeter Board.

#### 5. Sustainability Considerations

Contingency budget pressures have presented the highways service with a real challenge in maintaining the level of service for weed control. Increasing safety related activities dominate the budget setting considerations. However by introducing new, cost effective ways of delivery and by being flexible in managing the budget, the service has managed to sustain a reasonable level of service.

#### 6. Carbon Impact Considerations

This proposal will have a neutral carbon impact.

#### 7. Equality Considerations
