- 1. - 4. While there were a number of other issues raised by Independent Members as part of their observations, as set out below, there were no reports of any specific actions or behaviors that might be felt to have resulted in a potential breach of the Code or warranted further action. There was one unfortunate isolated case of an unidentified member apparently uttering a mild swearword which should not have happened as was immediately recognised and regretted by the reaction of those present at that particular meeting.
- 6. Specific observations by Independent Members were that:
  - Meetings had been well conducted and business dealt with appropriately;
  - there was robust questioning and challenge by Members of Reports and evidence submitted, but in a positive and constructive manner;
  - where late arrival of members was occasioned by, for example, significant traffic or severe
    weather events which resulted in concern as to whether or not the meeting might have
    been quorate, it may have been sensible for the Chairman to have delayed proceedings
    for a short while;
  - where members of the public and interested parties were permitted to attend and speak at certain meetings on specific matters they were treated with courtesy and respect – and quite obviously listened to;
  - the audibility of speakers/acoustics, particularly in the Council Chamber, continued to be a
    problem and at the budget meeting, in particular, it may not have been possible for those
    present or viewing the webcast to have heard all the declarations of interest at the
    beginning of the meeting. [NB: (i) A replacement system is being purchased and (ii) all
    interests are recorded in the minutes of the meeting and on the Councils website so that a
    full record is kept and publicly available];
  - firm, effective, Chairmanship was demonstrated in meetings, particular in relation to curtailing/avoiding 'separate meetings' or interruptions that might adversely affect the conduct of the meeting;
  - at Council meetings in particular there is a higher incidence of movement in and out the Chamber by Members and other which and be disruptive. .
