#### 14 Minutes

**RESOLVED** that the minutes of the meeting held on 15 July 2016 be signed as a correct record.

#### 15 Whimple Rail Users Group

Professor R Betts spoke on behalf of the Whimple Rail Users Group expressing his thanks to the Working Party for their work and achievements thus far on the Whimple line. The Users Group were keen to see the good service continue and to work with and support the Working Party into the future.

#### 16 Update from Network Rail

(Councillor Deed declared a personal interest in this item and all other items hereunder but did not speak by virtue of being in receipt of a pension from South West Trains.)

Mr D Northey, Senior Strategic Planner, gave a presentation covering, in particular:

- further Government funding of £10m for the proposed resilience scheme between Exeter and Newton Abbot;
- Exeter Exmouth (Avocet line) and Crediton Barnstaple (Tarka line) being key lines for improvement;
- faster journey times from the South West.

Matters discussed by Members with Mr Northey included:

- a long term strategy for climate change/flooding involving close working with the Environment Agency;
- initial work at Cowley Bridge involving additional drainage and removal of weirs;
- capacity issues and the need for additional rolling stock;
- North Devon/Tarka line the need to encourage rail users especially businesses to participate in the current survey;
- · rail freight forming part of long term strategy;
- safety concerns at Salmon Pool (Tarka line) and the need for installation of half barriers:
- Tavistock and the listed structure at Meldon how to bridge the gap?;
- ongoing capacity issues at Copplestone and additional rolling stock;
- the state of the sea wall at Teignmouth; the effect on tourism if beach is affected and the need for wave-breaking reefs to be considered.

Mr Northey acknowledged the following issues and would report further on the:

- timescale/funding for flooding resilience at Cowley, Bridgwater, the Somerset levels and Axminster;
- timescale for installation of half barriers at Salmon Pool (Tarka line).

#### 17 Update from Great Western Railway (GWR)

Mr L Ward, Regional Development Planning and Programme Manager, gave a presentation which covered:

- increased patronage on the Tarka/Avocet lines
- the new Intercity Express trains being tested;
- investing in the future of high speed services (Speed to the West);
- expanded car park at Tiverton Parkway;
- investment in station improvements;
- Exeter St David's Depot plans progressing;
- steady implementation of strategies additional Crediton service in the pipeline;
- Okehampton special charter train.

Matters discussed by Members with Mr Ward included:

- lack of bus flag and cycle shelter at Crediton Station;
- bridging the level crossing at Exeter;
- the date of an announcement from Government on Edginswell.






## Patronage – Barnstaple Line






## Patronage – Exmouth Line






### Patronage – Paignton/Plymouth Lines

All Day PPM: Period v MAA





Railway Reporting Period (year-period)

# **Performance** Devon Metro - Class 143 fleet







## **GWR** fleet update

- Intercity Express Train testing ongoing with a range of scenarios tested
- Anticipating the adjusted electrification programme we will have an entirely bi-mode fleet of new Intercity Express Trains meaning no electrification impact on introduction

Class 387 Electrostar presence is ramping up in the Thames Valley - Turbo cascade to Severn beach line starts this year. A bigger impact will be noticeable from end of this year as Class 150/2 numbers increase and we can strengthen key **Devon Metro** services before the big timetable change in Dec 2018

 Refurbishment of **Night Riviera** stock underway, the first seated coach already in service other seated coaches and berths entering service in coming months.






#### **New Stations involvement**

## Marsh Barton and Edginswell

- Marsh Barton has secured Network Change
- Edginswell has planning consent Page 15
  - Significant LEP and local authority investment
  - New Stations Fund bids made in November 2016
  - GWR part of Project Board, providing management time to assist planning and implementation







- 'Speed to the West' Study into journey time improvements between London and the South West peninsula
- Has informed the Peninsula Rail Task Force (PRTF) report to DfT on 20 year strategy

PRTF strategy also looking at long term resilience for the line

- Report published in November 2016
- Rail industry working with PRTF to look at next steps



Study funded by GWR to look at maximising the benefits of the AT300 trains



Platforms 1 – 9 at Waterloo and Up and Down Main Slow lines to Queenstown Road

Two lines closed so main suburban trains will share the Up and Down Main Fast lines with main line trains.

#### Major communications campaign started in August

- -'Phase 2' of that campaign started 26 January
- 60 events in stations and on trains completed
- Very high profile campaign, includes newspaper, online and radio advertising
- Also using on train and in station opportunities, announcements, posters, window stickers
- Welcome any help you can provide to reach passengers, businesses and other stakeholders

Summer 2017

#### What are we telling people?

- Publishing draft weekday morning timetable
- Publishing 'Trains per Hour' map for morning, evening and off peak for every station to help 'at a glance' planning
- Providing alternative travel advice where possible at the moment
- All of the above will be available online and is well in advance of industry standard and is intended to help passengers 'plan ahead'

# The impact on services and passenger journeys does vary by station and line of route:

• The following is based on the current plan and what we are telling passengers

Summer 2017

#### **Exeter St Davids - Crewkerne**

- Maintains frequency of 1 Train per Hour to and from Waterloo (morning, evening and off-peak)
- First departure from Exeter St Davids remains 05.10 (arrives into Waterloo 08.57)
- Expect London Waterloo to be much busier than usual, particularly if travelling home in the evening
- There may be systems in place to manage numbers in and out of station

Summer 2017

#### **Yeovil Junction - Overton**

- Reduced service to London Waterloo
- 1 Train per Hour instead of 2 during morning peak
- Some further changes off peak
- 1 Train per Hour from Waterloo during evening peak
- All trains will run at maximum length wherever possible

#### **Please Plan Ahead:**

- Check the advice for other stations nearby if possible. They might have more frequent or less crowded trains
- Travel earlier or later than normal. The busiest trains arrive into London between 8am and 9am and leave London between 5.30 and 6.30pm.
- Not travelling. If you are able to do so you might want to consider working from home or planning a holiday for some or all of this time

# Exe Rail Progress Report February 2017

#### **Marsh Barton Station**



- Construction delayed due to the need to revise designs to meet changing Network Rail standards.
- Likely to have an impact on scheme cost but this is yet to be fully quantified.
- DCC submitted a £3m bid to the New Stations Fund the result of which is expected to be announced in the spring.
- The start date for works will be no earlier than Autumn 2017. Currently looking into options to minimise length of construction programme.



#### Peninsula Rail Task Force (PRTF)



- Five Local Authorities (Devon, Torbay, Plymouth, Somerset & Cornwall) worked together to produce a 20 year strategy report.
- Three Point Plan
  - Resilience
  - Connectivity through improved journey times
  - Capacity/Quality
- Final report submitted to Government in November and are now awaiting a response.
- Reopening of line from Bere Alston to Tavistock, strengthening of sea wall at Dawlish, improvements to Waterloo line, resumption of regular services to Okehampton and flood defence at Cowley Bridge all mentioned





#### **Exeter St David's Station Forecourt**



- DCC is working with Great Western Railway, Network Rail and Exeter City Council to develop a masterplan for new station forecourt at Exeter St Davids.
- Key feature of this masterplan include the relocation of car parking; promotion of space for commercial and residential development; and the location of drop off points and bus stops.
- Plans to upgrade the depot to the rear of the station this is required to accommodate the rolling stock from December 2018.



#### **Exeter-Honiton**



- DCC recently submitted a bid to the Government's Local Majors Fund seeking £2.5m for design work to improve capacity and resilience for the route between Exeter and Castle Cary via Yeovil.
- Schemes would enable a half hourly frequency between Exeter and Honiton whilst also improving the diversionary route for Paddington-Plymouth/Penzance services in event of disruption at Cowley Bridge or Somerset Levels.
- The bid was unsuccessful so alternative funding streams to progress design work will be investigated.
- The LEP is commissioning timetabling work (with funding contribution from DCC) to identify extent of new double track sections required to significantly improve journey times between Exeter and Waterloo.

#### **Exmouth Station Redevelopment**



- Land transfers between DCC and Network Rail have now taken place with construction works anticipated to begin in the summer of 2017. These improvement works include:
  - Access to trains via front entrance at all times
  - Improved internal building configuration
  - New ramp to better standard gradient
  - Seat incorporated into outside perimeter of ramp
  - Automatic door
  - Prominent signage in line with new brand
- Construction works for the new M&S Simply Food store, being built on the side of the bus station, are nearly complete.
- Working with East Devon and local community on further interchange improvements






# Minute Item 20

#### **Newton Abbot Footbridge**



 Scheme will extend the current footbridge at Newton Abbot Station so that the station can be accessed from both sides of the railway including Brunel Industrial Estate and cycle routes to Kingsteignton / Bovey / Moretonhampstead / Teignmouth.



- Close to being signed off at the GRIP 3 stage. Hoping to secure planning permission and land this year so the scheme can be delivered when funds become available.
- Separate scheme being developed to create more direct route to town centre via Dark Arches

#### Okehampton/Tavistock



#### Okehampton

 Ambition to introduce regular future services between Okehampton and Exeter. DCC also working with Dartmoor Railway to develop options for a new station on the eastern edge of the town.



#### **Tavistock**

- The proposed reopening of the line between Bere Alston and Tavistock was included within the Peninsula Rail Task Force report and its hoped that an allocation of funds may be made available by Government to allow further scheme development work.
- Continuing to acquire land along the route.

#### **Franchise Updates**



 Award of new South Western rail franchise, serving the Exeter to London Waterloo route, to be determined by the DfT in April 2017. Incumbent operator Stagecoach and FirstGroup have both bid for the franchise. Successful bidder to take over/continue franchise in August 2017.



 Cross Country Trains recently consulted on a revised December 2017 timetable. The proposals included two trains per hour between Exeter St David's and Bristol Temple Meads through most of the day at expense of extensions to Paignton (with exception of one train per day). DfT decision awaited.



#### **Electric Bikes**



- Electric bike scheme in Exeter was launched in October - first of its type in the UK.
- Improves integration between rail stations and onwards destinations, particularly employment sites.
- The docking stations currently installed include:
  - Exeter Central Rail Station
  - Exeter University
  - Digby & Sowton Rail Station
  - Exeter Civic Centre
- Future phases include potential docking stations at Exeter St David's rail station, the proposed Marsh Barton rail station and other stations to the east of Exeter such as Pinhoe and Cranbrook.





#### **News in Brief**



 Bus real time information system expected to be launched in the spring, improving integration between rail and bus

#### Garden Villages/Towns

 Cullompton has been allocated funding for design work on a garden village development which could include a new rail station

#### Newcourt/Cranbrook Patronage

 Both enjoying high passenger numbers. Estimated figure of 80,000 trips in first year since Cranbrook opened and 73,000 in first year since Newcourt opened.

#### **Devon Metro Strategy – Going forward**



- Developing updated strategy to guide and inform future scheme development
- Being developed in tandem with emerging Greater Exeter Local Plan for growth in housing, employment etc. to 2040 and other local plans
- Will set clear strategy to inform outputs required through industry planning and critical schemes including Exeter area resignalling due around 2026
- Prioritises work on other enhancements including new stations, reopenings, capacity enhancements and accessibility improvements
- Focus on communications, marketing and publicity with TOCs and Devon and Cornwall Rail Partnership
- Inform future franchise priorities
