### Access to County Hall and Public Transport Links

Bus Services K, J, T and S operate from the High Street to County Hall (Topsham Road). To return to the High Street use Services K, J, T and R. Local Services to and from Dawlish, Teignmouth, Newton Abbot, Exmouth, Plymouth and Torbay all stop in Barrack Road which is a 5 minute walk from County Hall. Park and Ride Services operate from Sowton, Marsh Barton and Honiton Road with bus services direct to the High Street.

The nearest mainline railway stations are Exeter Central (5 minutes from the High Street) and St David's and St Thomas's both of which have regular bus services to the High Street. Bus Service H (which runs from St David's Station to the High Street) continues and stops in Wonford Road (at the top of Matford Lane shown on the map) a 2/3 minute walk from County Hall, en route to the RD&E Hospital (approximately a 10 minutes walk from County Hall, through Gras Lawn on Barrack Road).

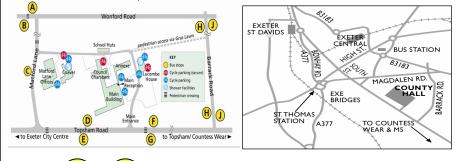
### Car Sharing

### Car Parking and Security

There is a pay and display car park, exclusively for the use of visitors, entered via Topsham Road. Current charges are: Up to 30 minutes – free; 1 hour - £1.10; 2 hours - £2.20; 4 hours - £4.40; 8 hours - £7. Please note that County Hall reception staff are not able to provide change for the parking meters.

As indicated above, parking cannot be guaranteed and visitors should allow themselves enough time to find alternative parking if necessary. Public car parking can be found at the Cathedral Quay or Magdalen Road Car Parks (approx. 20 minutes walk). There are two disabled parking bays within the visitor car park. Additional disabled parking bays are available in the staff car park. These can be accessed via the intercom at the entrance barrier to the staff car park.


## Good learning in RE

Agreed Syllabus Conference (ASC) meeting

### 1. Reviewing the existing Devon Agreed Syllabus

There was strong agreement with the conclusions coming through from the June SACRE meeting, that the current Agreed Syllabus (set up in 2013) needs a radical overhaul rather than a gentle tweak. The learning objectives need reworking, the unit titles are out of date and the support materials don't fully match the enquiry-led, knowledge-rich approach needed for an up-to-date curriculum. The current syllabus was written to rely on existing support materials and resources which were created in 2006. Most teachers say they are too stretched to spend the required planning time to create inspiring, challenging work in RE, so a new syllabus, which came well-resourced and supported would meet with widespread approval.

A questionnaire has been sent out to schools to gather information on the views of teachers from a wider cross-section across the county, with regard to the existing Agreed Syllabus. The results of this survey will be collated and analysed, and this will be reported on at the next SACRE meeting on 15<sup>th</sup> November.

### 2. Meeting with Dawn Stabb

Those present read the letter sent to Dawn Stabb (DCC lead for Education and Learning) in July, which set out options for change, and the salient points were discussed. A report was given of the meeting between Ed Pawson and Jeremy Roberts with Dawn on 5<sup>th</sup> September. It was recorded that she was in general agreement with the aim of providing a high quality RE syllabus, supported by detailed and accessible curriculum resources. However, she was concerned to ensure that the introduction of any new syllabus did not impose unrealistic and unnecessary financial demands on schools, especially LA schools. Those present at the meeting were in agreement with this ambition.

3. Need for a new Agreed Syllabus, supported by curriculum planning and resources It was agreed that there is a need for ALL schools to be able to access an up-to-date syllabus, supported by planning and materials written by skilled and experienced curriculum designers. Up to half of all schools in Devon (including most CofE schools) have now bought into and been trained in the Understanding Christianity approach to RE, mainly through courses provided by the Diocese of Exeter. This has created a step change in the teaching of Christianity, bringing a new level of confidence and expertise into RE classrooms. What these schools now say they need is a curriculum pattern that guides them through this material, and detailed plans and resources to enable them to teach about other religions and worldviews. This must be replicated across all schools in Devon.

### 4. Next steps

There was detailed discussion about the possible options, with agreement that any future syllabus must be backed up with high quality resources and support materials. Two options were discussed.

RE Today syllabus, medium term planning and accompanying schemes of work.

## Agenda Item 11

The 2017 Agreed Syllabus for Gloucestershire (written by RE Today) was looked at and was favourably received by those present. It has the advantage of having the Understanding Christianity resources written into its approach, so those schools that have already invested in these materials have a head start. These resources have been very well-received, so that gives confidence in the proposed new syllabus as a whole, given that it is written by the same team. The meeting gave its approval that this would be a favourable option for all schools.

Costings: The syllabus and medium term learning plans would come as a package, and these could be provided to all schools free of charge, with the cost defrayed by conference fees charged for the Agreed Syllabus launch events. The additional detailed schemes of work could be purchased from RE Today at a cost of £100-150 per primary school. This would resource them for the following 5 years.

### Helen Matter teaching resources

Many schools locally have found RE materials created by Helen Matter, written for schools following the Suffolk Agreed Syllabus, to be very effective and stimulating. They are clearly laid out and well-judged to create challenging learning experiences. However, these materials only cover KS1 and 2, and Helen will be retiring in 2019, so no future updates will be available. This option would require Devon SACRE to write an Agreed Syllabus which would reference and utilise these materials. This was a slightly less-preferred option, given the need to set up an experienced team to create a whole syllabus.

Costings: This option would require an Agreed Syllabus to be written. This would need about 10 days of consultant time, the cost of which could be defrayed against the money raised by teachers attending launch events. In addition, detailed schemes of work would cost schools in the region of £150 each.

### 5. Conclusions

The meeting concluded that either option would represent a positive way forward, and the Devon SACRE meeting set up for 15<sup>th</sup> November will provide a valuable opportunity to listen to presentations about these possible routes.

The overall plan is for the introduction of a new syllabus to be cost-neutral. Along with the RE Today syllabus, as part of the package, would come a set of medium-term planning across all key stages. This is designed to be sufficient for schools to enact good RE. Further than this, schools would be encouraged to buy the schemes of work package (£100-150 per school), but they could fulfil their expectations to teach good RE without this purchase. The Helen Matter option would provide an RE Agreed Syllabus free to all schools, but they would be required to pay for detailed schemes of work (~£150 per school) to support the implementation of this programme.

The meeting was at pains to point out that there will be adviser and teacher costs to this Agreed Syllabus review process. Devon County Council has a legal duty to provide a viable and up-to-date Agreed Syllabus for RE, so there needs to be a recognition that this requires an additional budget, over-and-above the annual SACRE expenditure. Having said this, every effort will be made to recoup all costs through the offer of a number of high quality launch events.

Paying for RE consultant time and for supply fees for teachers to attend the ASC meetings is essential.

Supply cover: 3 half day meetings for 4 teachers =  $3x4x\pm80 = \pm960$ Consultant time: 3 days @ $\pm350 = \pm1,050$
