#### Walking and Cycling Facilities

County Hall is a pleasant twenty minute walk from Exeter City Centre. Exeter is also one of six National Cycle demonstration towns and has an excellent network of dedicated cycle routes – a map can be found at: <a href="https://new.devon.gov.uk/travel/cycle/">https://new.devon.gov.uk/travel/cycle/</a>. Cycle stands are outside County Hall Main Reception and Lucombe House

#### Access to County Hall and Public Transport Links

Bus Services K, J, T and S operate from the High Street to County Hall (Topsham Road). To return to the High Street use Services K, J, T and R. Local Services to and from Dawlish, Teignmouth, Newton Abbot, Exmouth, Plymouth and Torbay all stop in Barrack Road which is a 5 minute walk from County Hall. Park and Ride Services operate from Sowton, Marsh Barton and Honiton Road with bus services direct to the High Street.

The nearest mainline railway stations are Exeter Central (5 minutes from the High Street) and St David's and St Thomas's both of which have regular bus services to the High Street. Bus Service H (which runs from St David's Station to the High Street) continues and stops in Wonford Road (at the top of Matford Lane shown on the map) a 2/3 minute walk from County Hall, en route to the RD&E Hospital (approximately a 10 minutes walk from County Hall, through Gras Lawn on Barrack Road).

#### Car Sharing

Carsharing allows people to benefit from the convenience of the car, whilst alleviating the associated problems of congestion and pollution. For more information see: <u>https://liftshare.com/uk/community/devon</u>.

#### Car Parking and Security

There is a pay and display car park, exclusively for the use of visitors, entered via Topsham Road. Current charges are: Up to 30 minutes – free; 1 hour - £1.10; 2 hours - £2.20; 4 hours - £4.40; 8 hours - £7. Please note that County Hall reception staff are not able to provide change for the parking meters.

As indicated above, parking cannot be guaranteed and visitors should allow themselves enough time to find alternative parking if necessary. Public car parking can be found at the Cathedral Quay or Magdalen Road Car Parks (approx. 20 minutes walk). There are two disabled parking bays within the visitor car park. Additional disabled parking bays are available in the staff car park. These can be accessed via the intercom at the entrance barrier to the staff car park.

## PROPOSAL FOR THE APPOINTMENT TO THE POST OF CHIEF OFFICER FOR CHILDREN'S SERVICES AND CONFIRMATION OF THE POST OF INTERIM DIRECTOR OF IMPROVEMENT FOR CHILDREN'S SERVICES.

## REPORT OF THE CHIEF EXECUTIVE AND COUNTY SOLICITOR

### Recommendation: that the Committee:

- (a) endorse the proposal to commence recruitment to the permanent appointment for the post of Chief Officer for Children's Services; and
- (b) endorse the interim appointment of Vivien Lines as Improvement Director within Children's Social Care until March 2022.

### 1. Introduction

- 1.1 The current Chief Officer for Children's Services, Jo Olsson, commenced with Devon as an interim in March 2016 and took up a permanent position in the role in 2017. In July 2020 the authority was informed of the post holder's decision to retire in January 2021.
- 1.2 The Chief Officer post holds responsibility for the following key service areas within Devon County Council:
  - Children's Social Care
  - Education & Learning
  - Children's Commissioning
  - Public Health Nursing
- 1.3 The service area is facing a rapid improvement journey following the outcome of an ILACS inspection in early 2020 that deemed the service Inadequate.
- 1.4 The improvements required within Children's Social Care must be sustained and the new appointment will need to continue to ensure that the service works towards a 'good' outcome in the next stage of the Improvement process.

## 2. Chief Officer for Children's Services

- 2.2 It is proposed that the vacancy will be recruited to on a permanent basis at its current L1 salary level of £137,965 (subject to April 2020 pay award negotiations)
- 2.3 A robust recruitment process will be used to provide assurance of the expertise, knowledge and skills required for the post of Chief Officer for Children's Services.
- 2.4 The recruitment process will ensure that the new Chief Officer for Children's Services demonstrates the leadership behaviours identified as part of the 'Doing What Matters' activity within Devon County Council.
- 2.5 The recruitment process would commence following the necessary approval process to ensure a replacement is identified and time for suitable handover periods are achieved.
- 2.6 The proposal to recruit a direct replacement has support from Eleanor Brazil, Devon County Councils appointed Children's Commissioner.

2.7 It is acknowledged that this replacement will commence close to the local elections in May 2021. In light of this it is felt that that this permanent appointment is necessary following the recent Ofsted outcome and the need to provide stability of leadership for Children's services.

## 3. Interim Improvement Director

- 3.1 On the 6<sup>th</sup> April 2020 the Council appointed an Interim Improvement Lead within Children's Social Care. As this is an interim appointment the Chief Executive is authorised to make this decision.
- 3.2 The interim Improvement Director's task is to oversee the development and delivery of the Children's Services Improvement Plan to ensure improvements in the 4 key strands of improvement as identified following the OFSTED inspection.
- 3.3 The interim postholder who reports to the Chief Officer will maintain oversight on the 4 key identified areas of improvement that are:
  - Experiences of and progress for Care Leavers
  - Experiences of and progress for Looked After Children
  - Children at risk of chronic neglect and emotional abuse
  - The impact of leaders and managers on social work practice for children and families
- 3.4 The successful interim candidate, Vivien Lines, has a range of skills and experience and a track record of delivery in a post at this level which will enable Devon to deliver the service improvement agenda.
- 3.5 The interim placement costs £1,100 per day. The post is deemed as inside IR35 and as such an additional cost for NI and Apprenticeship Levy is charged in addition.
- 3.6 The committee is asked to note and endorse the appointment for the period until March 2022.

## 4. Conclusion

- 4.1 It is recommended that the Appointments, Remuneration and Chief Officer Conduct Committee endorse the proposal to advertise for a permanent replacement for the Chief Officer for Children's Services
- 4.2 It is recommended that Appointments, Remuneration and Chief Officer Conduct Committee endorse the appointment of the Interim Improvement Director post to March 2022.
