The minutes of the meeting held on 23 June 2023 were signed as a correct record of the meeting.

40 <u>Items Requiring Urgent Attention</u>

There was no item raised requiring urgent attention.

41 <u>Learn Teach Lead RE: Update</u>

The annual conference took place on 13 October 2023 and was well received. Future training for hub leaders are planned within the current academic year. Hubs continue to meet, some virtually whilst other have moved to in person. The autumn meeting for the Exeter Hub will be held at the Quaker House. The Committee welcomed that £1000 would be made to the LearnTeachLead RE from the SACRE budget.

* 42 Devon and Torbay SACRE - Agreed Syllabus Review

The Committee noted that the new syllabus would be introduced from September 2024, launch events are schedule in June 2024 across Devon, Torbay and Plymouth.

Changes to the syllabus included:

- · Updated forewords, introduction and cover
- Updated language from 'religion and belief' to 'religion and worldviews', in line with CoRE
- Updated language from 'religious and non-religious beliefs' to 'religious and non-religious worldviews'
- Adjust language (e.g. Hinduism to Hindi dharma)
- Make non-religious worldviews, specifically Humanism, more visible:
 - What does it mean to be Humanist in Britain today?' including some of the reasons for and against belief in God as part of this.
 - What difference does it make to be an atheist or agnostic in Britain today? to include some more specific study of Humanism but also more recent data on non-religiousness/Nones.
- Updated Early Years
- Addition of opportunities to add examples showing more diversity in the impact sections of units (e.g. more global and local examples of Christian harvest celebrations, prayer, grace)
- Addition of more examples of more local Devon/Torbay/Plymouth/SouthWest places in some of the units
- Updated demographics to 2021 Census

During general discussion, it was questioned how Church Schools would use the curriculum and it was welcomed that it had not changed significantly.

In response to confirmation about the County Council underwriting the syllabus cost, it was noted that an easily transmitted document would be circulated after the launch date and delegates would pay to attend the training sessions.

Educational settings would not be charged for document as costs would have been recouped through nominal delegate training fees through the Schools Effectiveness budget. It was noted that academy schools would pay for the curriculum document.

44 Equality, Diversity and Inclusion in Devon schools

Lorna Legg, Head Teacher at Ofwell Church of England Primary School led a session on equality, diversity and inclusion in Devon schools.

The presentation highlighted the following points:

- importance of language used
- treat everyone with equal respect, always aim to see the individual before the group
- avoidance of phrases which are reductive and perpetuate stereotyping
- aim not to cause offence, but be alert to apologise and learn rather than blame the victim
- make the effort to find out more information

During general discussion the following issues were raised

- barriers and prejudices around religion, race, culture, class, poverty
- what prevents children learning about other religions and worldviews
- how can schools be more aware of diversity and be more inclusive
- · the recent ongoing refugee crisis
- hate crime in Devon
- whether training should be mandatory in educational settings

In reference to the report showing some schools who were in need of help and assistance, further advice and guidance would be offered to offer curriculum support in specified areas.

46 <u>Regional and National Developments - RE Hubs, National Content Standard in RE</u>

During general discussion the Committee was **NOTED** the report and that the RE Hubs website was available at https://www.re-hubs.uk. Information on the website included courses and events, local groups and how to contact your local hub.

The Religious Education Council have released the national content standard for RE. the vision for every young person to experience an academically rigorous and inspiring education in religion and worldviews. Publication of a national Content Standard provides clarification and a benchmark for excellence in religion and world views in England. The RE Council's National Content Standard provided a non-statutory benchmark for syllabus providers and other bodies to evaluate engagement in relation to religion and belief.

Content included:

how world views are formed; relate to a wider institutional world view; feature continuity and change; offer responses; provide guidance on how to live a good life; are influenced by people and societies.

In Spring 2024 the REC Religion and Worldviews project will publish new religion and worldviews frameworks.

Ben Bradshaw MP had written to Nick Gibb MP (Schools minister). It was noted that the reply from Nick Gibb MP did not seem to acknowledge or address the critical shortage of RE teachers.

It was also noted that the DfE has recently responded to this issue by reinstating a bursary of £10,000 for trainee RE teachers.

The letter therefore has been part of a successful campaign to address the recruitment crisis, and SACRE thanked Councillor Adams for her intervention.

49 Young Ambassadors Project

The Committee **NOTED** that the Devon SACRE Advisor and staff at Dartmoor Multi Academy Trust would be undertaking work to train and empower a group of primary and secondary students to become Ambassadors for Freedom of Religion or Belief.

The project aimed that the young Ambassador's would work with the students at Okehampton Primary School and Okehampton College, towards a significant community event in 2024. This would be followed by a visit to Westminster in June 2025 to address MPs and Lords about the importance of RE.

The project is led by the Association of RE Inspectors and Advisers (AREIAC) and funded by Culham St Gabriel's Trust.

1. Key points and Summary

- 1.1 The purpose of this report is to update SACRE members on the progress of the review of the Devon and Torbay Agreed Syllabus.
- 1.2 The new syllabus will be completed by the end of March, ready for the launch in the summer term.
- 1.3 The new syllabus will be introduced for teaching from Sept 2024
- 1.4 Syllabus launch events are planned to take place across Devon and Plymouth on Mon 17th, Tues 18th, Wed 19th June 2024, led by syllabus-writers Fiona Moss and Stephen Pett (RE Today).
- 1.5 The cost of the new syllabus will be £35 per school. SACRE has the assurance from the Local Authority that it will pay for a copy of the syllabus to go to every school in Devon (including academies). A significant proportion of this cost will be recouped through the 'paid-for' launch events.
- 1.6 There will need to be ongoing training for teachers as a follow-up to the introduction of this new syllabus, partly via the LTLRE conference and hub meetings.

Key points and Summary

1 Introducing the RE Hubs project

The RE Hubs project is now well established. SACRE members are encouraged to visit the website and explore what it has to offer: a calendar of CPD events, details of school speakers and places of worship/interest, an extensive library of resources to support schools provide better RE etc

2 Ofsted reports

2.1 HMCl's report

In November 2023 Ofsted published its HMCI's <u>annual report</u> for 2022/3. This report stated the following:

'in too many primary and secondary schools, the religious education (RE) that pupils receive is of a poor quality and not fit for purpose, leaving pupils ill-equipped for some of the complexities of contemporary society.'

'RE is a complex subject, and the lack of clarity and support from government makes schools' job harder.'

These comments are very hard hitting, and back up many of the observations that have been made by members of Devon SACRE over a number of years.

Suggestion: to write to the Secretary of State for Education demanding that the DfE produces a plan to show how RE will be given more status and priority in schools. This includes dealing with the recruitment crisis and supporting the subject through mechanisms like the RE Hubs project.

2.2 RE subject report

We are awaiting the publication of a long subject report on RE. This will give school a analysis of the state of RER in our schools.

3 National Content Standard for RE (NCS)

How do we measure the quantity and quality of RE provision?

The National Content Standard for RE is needed to provide clarification, bring consistency and to raise standards. Educational organisations continue to sign up to show their acceptance of this mechanism which creates a standard for a school's RE provision.

The RE Council's National Content Standard provides a non-statutory benchmark for syllabus providers and other bodies to evaluate their work. It is not a curriculum, and it does not determine precisely what content schools should teach. Rather it is a standard by which different RE curricula, content, pedagogy, and provision can be benchmarked

4 Religion and Worldviews frameworks

The Religious Education Council (REC) will be publishing its long-awaited Religion and Worldviews frameworks in May. These resources will show how the Religion and worldviews approach can be put into practice in classrooms. More details at the next meeting.

2 SACRE's statutory responsibilities

Review of the Local Agreed Syllabus

Work has been ongoing to review the current Agreed Syllabus for RE (AS), which runs from 2019-2024.

During the year an Agreed Syllabus Conference (ASC) was set up to advise SACRE in how to proceed with the AS review. The ASC fed back to the full meetings with its findings. The ASC considered whether the introduction of a new syllabus should be delayed beyond 2024, given the expected publication of new exemplar frameworks on a worldviews approach in 2024. However, it was agreed that a new, updated syllabus is needed in 2024 to ensure that schools continue to see the SACRE syllabus as the most fit-for-purpose way to teach high quality RE.

This review is taking place in conjunction with Torbay, Plymouth and Cornwall SACRES, (although Cornwall's AS runs until 2025). Teacher panels and online surveys have been utilsed to gain feedback on the way the current syllabus is working, and to gather views on what needs changing or updating. Evidence shows that the current syllabus, which marked a significant change from the last one, has been well received by teachers and schools. This means the new syllabus will not look radically different from the current model. However, there is a need for it to embody the significant changes in approach to the subject and new



ideas being introduced at a national level, in particular around a developing understanding about a religion and worldviews approach.

RE Today have been working on this update and will be presenting a draft version in Autumn 2023.

SACRE wants the LA to be aware that additional resources will be required for the introduction of a new syllabus. The LA has indicated that it is prepared to underwrite the changes being proposed.

Here is a summary of changes to the AS:

- Availability of more 'lesson-ready' resources
- Teaching units to embody more diversity
- Teaching units to reflect the local lived experience of people's religious and non-religious worldviews
- More input on Humanism required in primary phase
- More detail on assessment
- More input for special schools
- More input on progression in language and vocabulary across the syllabus
- Updated use of terminology and information on demographics
- More materials on how to link learning into local places of interest and places of worship

Launch events are planned for June 2024 with teachers being offered opportunities for follow-up training

Standards and monitoring in RE

Secondary schools

Data from the DfE annual workforce survey points to the fact that a number of local secondary schools do not teach any/enough RE. Schools have been contacted and conversations with headteachers and senior leaders have taken place to explore further and offer input to enable them to develop the place of RE in the curriculum.

GCSE exam results 2022

Appendix 1 shows entry data for Devon schools for 2019-23 GCSE exams. This chart shows that the percentage of Y11 cohort in Devon schools who were entered for GCSE RS has dropped by more than half in the last 5 years from 58% in 2018 to 27% in 2023. This fall demonstrates a significant reduction and is mainly explained by a (national) trend that is seeing schools moving away from entering their full Y11 cohort for the GCSE RS exam, moving towards entry via more limited option groups. In some ways this is a positive shift, where schools are more accurately targeting students who want to study RS as an exam subject. However, it raises the question: what RE is being offered as part of the core curriculum, for those students who do not opt for the GCSE option. This is something which has been raised with a number of Devon schools in conversation over the last year, to explain the legal requirement that schools offer 5% of curriculum time at KS3 and 4. In terms of attainment, Devon schools are significantly below the national average. However, Devon schools have caught up a bit over recent years which is encouraging. The national average for level 9 is 29%, as opposed to 24% in Devon. The national average for level 5-9 is 60%, as opposed to 53% in Devon. This continues to raise concerns about standards in local schools.

Primary schools

Monitoring of RE in primary schools continues through sampling of websites and scrutiny of recent Ofsted reports. Schools have been contacted where issues arise or where RE does not appear to be taught or delivered well. Visits have been made to schools where their Ofsted report has highlighted weaknesses in RE or related areas. Where RE is mentioned positively schools have been contacted to thank them for their strong provision. Resources have been shared and advice has been given to a number of schools with regard to parental requests for withdrawal from RE (and/or collective worship).

Monitoring RE in Multi-Academy Trusts

Devon SACRE continues to monitor RE in schools which are in Multi-Academy Trusts (MATs) to ensure that RE is given its statutory place in the curriculum. There are an increasing number of MATs who have appointed RE leads across their schools, which is a positive development. SACRE, along with NATRE and RE Hubs, is active in drawing these hub leaders together and working with them to develop an understanding of how MATs need to make provision for the subject.

3 Collective Worship

Guidance from Devon SACRE on <u>collective worship</u> and school assemblies has been well received by schools. This guidance supports schools in developing an up-to-date policy and encouraging active pupil participation in collective worship/assemblies. We want to help schools put in place effective practice, offering opportunities for reflective experiences for their pupils. The guidance document offers an explanation of the legal obligations, including the right to withdrawal, and outlines some of the rich opportunities that assemblies/collective worship can offer pupils for spiritual, moral, social, cultural and personal development.

There have been no formal complaints about collective worship in schools and no applications for determinations.

4 Links with other bodies

Devon SACRE has strong links and partnerships with a number of organisations. It works closely with Devon County Council, the Diocese of Exeter and the University of Exeter. The SACRE adviser coordinates the SW <u>AREIAC</u> network of advisers (SWARE), and organises the annual SW SACRE conference. We were pleased to invite Trevor Cooling (former Chair of the RE Council) to speak at the 2023 SW SACRE conference, with a number of other workshops offering a range of important inputs for SACRE member training.

SACRE members and SACRE advisers across the SW often collaborate and share training and initiatives. A number of SACRE members have accessed training from MASACRE and the adviser attended the NASACRE national conference in May 2023 in London.

SACRE has discussed issues raised in recent NASACRE reports. The Still Standing <u>report</u> has helped SACRE members consider how SACREs may need to evolve their membership to be responsive to the representation of the diversity of local religion and worldviews communities.

SACRE members continue to be fully informed about national developments being made by the <u>REC</u>. In particular to understand how a new vision for RE is being developed through a worldviews approach. SACRE is aware of the new national Religion and Worldviews <u>resource</u> which has been produced to enable syllabus writers to construct a new generation of RE syllabi. SACRE members are fully supportive of development of a National Content Standard for RE.

SACRE works closely with the Devon Faith and Belief Forum to establish strong links to local faith and belief organisations. This enables schools to draw on visitors to school classrooms and to inform who will be the most suitable faith and belief representatives when member vacancies occur.

Learn, Teach, Lead RE

Devon SACRE is pleased to continue its support of the Learn, Teach, Lead RE programme (<u>LTLRE</u>). Devon hubs are working well to support teachers of RE, offering termly twilight meetings and networking opportunities.

The recent evaluation of the programme has brought forward a number of recommendations which are being put in place. This includes a better system for sending out hub meeting dates in advance, and encouraging more recognition for the hub leaders' roles from their leadership teams in their schools.

A teacher survey with regard to LTLRE showed that engagement with a local hub had given teachers greater confidence in leading RE and Hub leaders were reported as approachable and supportive.

The LTLRE conference in October 2022 took place online and attracted over 100 delegates. Feedback was very positive, valuing the input from speakers and workshops. Delegates were especially interested in the address from Dr Richard Kueh, Ofsted lead for RE.

5 SACRE: local involvement

The half termly RE newsletter gives schools in depth support, information and networking links. It signposts current CPD, hub groups and conferences. Though it SACRE sign-posts guidance to schools about significant events, eg religious festivals such as Easter, Ramadan and Diwali, Interfaith Week etc

SACRE officers organise Holocaust Memorial Day events for schools every year. On Holocaust Memorial Day in January 2023 a service was held at Exeter Cathedral where schools participated in remembrance and reflection. The key speaker, Rob Rinder (AKA Judge Rob), attracted a large audience and much media attention. Over 200 school pupils were involved in the Exeter events from eight schools across the County. Presentations were given on Kindertransport and the Gypsy Holocaust. The closing ceremony was hosted by the Jewish community.

HMD resources and <u>links</u> were shared with schools.

6 SACRE: regional and national involvement

Following a presentation from Exeter University about the current shortage of secondary RE teachers SACRE members have expressed concern about the recruitment and retention crisis facing the subject. Consequently a letter was sent to Nick Gibb (schools minister) to raise this issue with the Department of Education.

SACRE has been keen to be updated on the development of the <u>RE Hubs</u> initiative, which is providing teachers with a 'one-stop-shop' website, offering links to school speakers, places of interest, CPD events, local network groups, blogs and resources etc.

7 SACRE organisation

Devon SACRE is well served through its clerk (Yvette Welsh), LA lead (Simon Bissett) and adviser (Ed Pawson). Devon County Council is responsive to SACRE's needs and supportive in its administration and organisation. It is well supported financially.

In July 2022 the administration of SACRE was transferred back to Devon County Council, along with all systems and materials previously available on the Babcock website. SACRE membership is vibrant and well-engaged, although there are still a few important vacancies. The new SACRE constitution, approved by DCC in Feb 2023, stipulates that SACRE members will serve a 4 year period, followed by a further 4 year period, if invited to continue. After this (8 years) most SACRE members will come off SACRE, to allow others to join and gain the valuable experience of being on this body. This change will begin to be enacted in 2024.

SACRE is aware of the need to continue to increase the diversity of its representation, and it is a priority to bring in some training on diversity for SACRE members. All meetings in the year 2021/2 have been quorate.

A number of SACRE members have taken advantage of useful training opportunities over the last year, both through attendance at the SW SACRE conference and national online NASACRE training events.


During 2021/2 SACRE reviewed its constitution, through input from a working party. This needs to be signed off by Devon County Council.

Dear Ms Twiggs,

Thank you for your letter regarding religious education.

I strongly believe in the importance of RE for developing pupils' understanding of the rich diversity of faiths and communities and their role in shaping the values and traditions of Britain and other countries. Indeed, these are some of the reasons why RE is a statutory part of the curriculum. The syllabus is not, however, set by the Government, but locally by schools and local authorities.

The Department for Education welcomed the publication of Ofsted's research review into RE in May 2021, particularly given that it sought to identify factors that contribute to high quality RE curricula and teaching in schools. The Government's policy is to allow the RE curricula to be designed at a local level, through locally agreed syllabuses or by individual schools and academy trusts developing their own curriculum. Whilst it is important that the review is taken into account, the Government does not prescribe how much time a school devotes to any individual subjects, including RE. It is for individual schools to plan, organise and deliver their own curriculum.

While all schools must teach RE, academies have the freedom to set their own curriculum under the terms of their funding agreements, and voluntary aided faith schools can teach RE in accordance with their faith.

To ensure high standards of RE teaching, resources will be procured by Oak National Academy during the second tranche of its work. Oak will work closely with the sector and utilise sector experience when producing new materials for RE. This will ensure that high quality lessons are available nationwide, benefitting both teachers and pupils, should schools opt to use them.

To support high standards of RE teaching in all schools, the Department is continuing to offer eight-week subject knowledge enhancement (SKE) courses for candidates who have the potential to become outstanding teachers, but need to increase their subject knowledge. The eight-week SKE course, available in RE, can be undertaken on a full time or part time basis, but must be completed before qualified teacher status can be recommended and awarded. Eligible candidates could be entitled to a SKE bursary of £175 per week to support them financially whilst completing their SKE course.
