* 93 Minutes

* 94 Items Requiring Urgent Attention

There was no item raised that needed urgent attention.

* 95 <u>Devon SACRE Membership Updates</u>

The Committee took a moment of contemplation to remember Saxon Spence, who had been a member of Devon SACRE for many years.

* 96 <u>Devon SACRE Annual report 2023/2024</u>

The Committee heard and **NOTED** that the annual report had been finalised and sent to the Department for Education. It was noted that the foreward written by the previous chair of Devon SACRE comments included about the excellent support of the RE advisor and the outstanding work of Learn Teach Lead RE through local hubs.

97 Data from Schools

The Committee received and **NOTED** data collected regarding RE provision in schools.

The Committee noted the Religious Studies GCSE entries and their outcomes and concern about the drop in the number of students being entered for the GCSE RS exam. The percentage of Year 11 cohort entered for 2024 was 25.7%, a decrease from 44.8% in 2022. In 2024 only 56 entries were made for A level students

During general discussion the following points were made

- funding could be the reason that Religious Studies was not offered as a GCSE subject in some schools due to the lack of specialist teaching staff:
- the RE curriculum has been found not to be up to date in some schools;
- ongoing collaborative work could be offered to help assist with teaching;
- concern that some church school figures were not as positive as expected;
- that A Level Religious Studies was not offered as a subject at either Exeter College or Petroc College.

The Committee suggested that the Diocese be approached regarding results of church aided schools and the RE Adviser should make contact with schools who are not offering RS as a GCSE option.

98 Standards in Schools - Monitoring and Ofsted

The Committee **NOTED** the Ofsted reports for November 2024 – January 2025. They heard that a letter of congratulations had been sent by the RE Adviser to those schools where RE had been praised in a recent Ofsted

report. Schools were also contacted to offer support where the report showed concerns.

During general discussion it was suggested that the Governors be contacted where a school had not received a favourable result to offer advice and guidance.

* 99 <u>Devon and Torbay SACRE: Agreed Syllabus</u>

The Committee **NOTED** that feedback would be given at the next meeting following the results of a teachers' survey, to be carried out in May.

It was noted by colleagues of the Committee that the new syllabus had been very well received so far.

* 100 Learn Teach Lead RE

The Committee **NOTED** that Hub leaders training during 2024/25 would take place on 7 March 2025 and 4 July 2025 and £1,000 would be made to Learn Teach Lead RE hubs for the academic year 2024/25 as set out in the SACRE development plan.

The LTLRE hub groups in Devon continue to be successful, with termly meetings attracting both primary and secondary teachers of RE. The meetings take place both in person and online, dependent on the context and topic being covered.

The new hub leaders are:
Shana Bartram-Owen and Amber Griffiths in Mid-Devon
Lisa Lowe in East Devon
Shelley Moss in South Devon/Torbay
Zoe Bullamore in North Devon.

The next annual conference is planned for October 2025.

* 101 Regional and National Developments: RE Hubs, Curriculum, and Assessment Review

The Committee were reminded about the RE Hubs and the information available.

They also heard about the NATRE response to the curriculum and assessment review, which included:

- that NATRE highlighted the importance and critical role that RE plays within the curriculum
- Pupil feedback
- Absence of accountability measures for academies and outdated content

102 Young Ambassadors Project

Pupils from Okehampton College and Okehampton Primary School, both members of the Dartmoor Multi-Academy Trust, are taking part in the two year project.

The Ambassadors have been involved in:

- Participation in an online discussion with the Parliamentary Commissioner for Standards, Lead Consultant for Advocacy for Culham St Gabriel's Trust, and AREIAC executive joint chair
- Creation of a display for Interfaith Week
- Setting up a Christian Union,
- Speaking at the Opening Ceremony for Holocaust Memorial Day commemoration events in Exeter
