Various roads in Exeter	Introduction and removal of mandatory disabled bays	Traffic regulation order advertised, and restrictions implemented after consultation with Local County Councillors and HATOC Chair as no objections received for bays in this area.
Denmark Road	Amended parking restrictions for new vehicle access	Traffic regulation order advertised, objections resolved, order modified and restrictions implemented after consultation with Local County Councillor and HATOC Chair.
Willeys Avenue	Amended parking restrictions for new vehicle access	Traffic regulation order advertised, and restrictions implemented after consultation with Local County Councillor and HATOC Chair as no objections received.
Wonford Road	Removal of a residents parking bay for widened vehicle access	Traffic regulation order advertised, objections resolved, and restrictions not progressed after consultation with Local County Councillor and HATOC Chair.
New Access - Rifford Road, Exeter	Removal of a residents parking bay for widened vehicle access	Traffic regulation order advertised, and restrictions implemented after consultation with Local County Councillor and HATOC Chair as no objections received.
New Access - Dryden Road, Exeter	Removal of a residents parking bay for widened vehicle access	Traffic regulation order advertised, and restrictions implemented after consultation with Local County Councillor and HATOC Chair as no objections received.

Chestnut Avenue	Relocate disabled bay for new vehicle access	Traffic regulation order advertised, objections resolved, and restrictions implemented after consultation with Local County Councillor and HATOC Chair.
Various roads in Exeter and Topsham	Introduction of car club bays and an electric vehicle recharging bay	Traffic regulation order advertised, objections resolved, and restrictions being implemented after consultation with Local County Councillor and HATOC Chair.
Albatross Road	Introduction of car club bay and an electric vehicle recharging bay	Traffic regulation order advertised, and restrictions implemented after consultation with Local County Councillor and HATOC Chair as no objections received.
