## **Teign Estuary Trail Public Consultation**

I am writing to ask if you will make a decision in accordance with Paragraph 11 of the County Council's Scheme of Delegation by approving progression to public consultation on a proposed section of the Teign Estuary Trail from Passage House Inn to the west fringe of Teignmouth, locally known as Morrison's junction.

The Teign Estuary Trail seeks to complete the 'missing link' of the National Cycle Network Route 2, connecting Newton Abbot to Exeter via the Exe Estuary Trail. Connecting Dawlish, Teignmouth and Newton Abbot through the extension of the Teign and Exe Estuary Trails would form a national showcase supporting leisure as well as local cycling utility trips, providing economic and health benefits.

The Teign Estuary Trail remains a long-term aspiration for Devon County Council and the current strategy is for the route to be delivered incrementally, with some sections having already been delivered. Design work has continued to progress on the outstanding sections, and in March 2019, Devon County Council and Teignbridge District Council each committed £200,000 to progress a planning application between the Passage House Inn and Teignmouth.

We would like to progress to public consultation in advance of the planning application submission in order to obtain feedback on the scheme design, route strategy and provide information on the project's next steps. Although a face-to-face exhibition will not be possible under current COVID-19 restrictions, the consultation will be advertised to ensure local communities have the opportunity to engage in the process.
