CHAIR'S REVIEW

The year of the COVID-19 pandemic has been unlike any other in the Council's history. By necessity the activities of elected members have changed from a typical years' focus on policy development and review to supporting positive governance and community leadership during this time.

Working remotely has not meant that Scrutiny has slowed pace, but has continued to strive to support the voice of local residents and pursue issues of concern. For Children's, this has entailed the deep dive into Ofsted related issues, with the first meeting only a couple of weeks into the first lockdown. Corporate Scrutiny has looked at 5G and maintained work on problem gambling, lobbying government on both issues. Health and Adult Care has continued to represent the views of local people, and even made a referral to the Secretary of State for Health and Social Care.

Scrutiny Chairs express their thanks to all Scrutiny Committee Members, across the four year term. The support of the dedicated Scrutiny team, coupled with the expertise offered by the two special advisors continues to be critical to the success of scrutiny.

Problem Gambling

Work has continued through Scrutiny to progress support for problem gamblers. The Committee has had conversation with the Minister and waits for the results of the review of the Gambling Act.



As part of the budget process, Scrutiny asked for more money to be put in to highway maintenance, and Cabinet agreed to an extra £600,000.

Modernising Health and Care Services in Teignmouth and Dawlish

Responding to local resident concerns at the lack of consultation on the future of the Teignmouth Community Hospital Scrutiny has now been referred to the Secretary of State for Health and Social Care. NHS Devon CCG has advised that following Scrutiny's involvement there have been a number of learning points for how they will run consultations in the future.





Children's Scrutiny responded quickly to the Children's Social Care Ofsted inspection and closely monitors the Improvement Plan across all meetings.



5G Spotlight ReviewScrutiny lobbied on behalf of local residents to reflect concerns. These have now been taken up by the DCMS Select Committee.
