
Consultation Results and Progression of Traffic Regulation Order

Dryden Road - Background

- **Mixed responses** to initial temporary measures
 - 53% positive & 47% against
- At HaTOC 13th October 2020 it was decided that
 - temporary arrangements remain in place until review at a future HaTOC meeting
 - Consult with local residents & Stakeholders

• Consultation

- 3 weeks Feb 17^{th} to March 10^{th}
- Online questionnaire
- Online exhibition & online Q&A
- 600 Public Responses
- Resurfacing of Dryden Road planned for 2022



Consultation Overview

The **four different options** proposed as part of the consultation were;

- Option 1 **Make current** vehicle closure between Well Oak Park and Kipling Drive **permanent**
- Option 2 **Move closure east** to between The Cedars and Bovemoor's Lane junction
- Option 3 **One way eastbound** between Well Oak Park and Kipling Drive
- Option 4 **Return to two way traffic**



Consultation Responses – Public (600 responses)

56% supported a permanent reduction in through traffic on Dryden Road.

- Rest of Exeter in favour.



Rankings of Traffic Reduction Options

"If a new closure or part closure of Dryden Road were progressed which option would you favour?"

and then asked to rank the 3 reduced traffic options in order of preference.

3 - Dryden Road One-way eastbound only between Well Oak Park and Kipling Drive	29%	12%	59%

Proposed Next Steps

- Further discussion with RD&E to identify any changes to alleviate Bovemoors Lane that could help mitigate their concerns.
- Progress advertisement of Traffic Regulation Order for point closure and measures to reinforce 20 mph speed limit
- Decision on construction of any scheme to come before a **future meeting** of the Exeter Highways and Traffic Orders committee.
