DEDICATED SCHOOLS GRANT 2022/23: BUDGET PLANNING

REPORT OF THE DIRECTOR OF FINANCE AND CHIEF OFFICER OF CHILDREN'S SERVICES

Recommendations

It is recommended that Schools Forum:

- a) Note the Dedicated Schools Grant (DSG) Deficit as set out in section 1.
- b) Note the DSG 2022/23 announcement on 17 December 2021 as set out in section 2.
- c) Vote the Schools Block including amendment to the sparsity calculation as set out in section 3
- d) Note the Central School Services Block, High Needs Block and Early Years Block as set out in section 4 to 9

Dedicated Schools Grant 2022/23: Budget Planning

1. DSG Deficit & Management Plan

- 1.1. As part of budget preparation, we are projecting to see the Dedicated Schools Grant (DSG) deficit increase by a further £27 million. This is despite the fact that the High Needs Block has increased by £12.5 million after deductions for direct funded places. The main reason for this increase in the projected deficit is the continued demand being put on the service for SEN placements.
- 1.2. The current projection to March 2022 is a cumulative DSG deficit of £88.1 million and when the 2022/23 projected deficit is added to this the cumulative deficit is just over £115 million by March 2023.

- 1.3. The Authority is very concerned over the ability to reduce this pressure and bring this back to a balance budget over the coming years. This could have a considerable impact on future education budgets within the DSG as well as impacting on the financial stability for Devon County Council.
- 1.4. A management plan has been developed and submitted to the DfE and the authority has now been invited to take part 2nd tranche of the Safety Valve Intervention Programme. The initial meeting of which has taken place between the Chief Executive, Director of Children's Services and Director of Finance and representatives from the DfE.
- 1.5. Deep dive meetings with SEN and Finance staff are expected to take place in early 2022 and an initial proposal to be submitted by mid-February.
- 1.6. Children's Service and Finance are continuing to work on updating the management plan and it is necessary to work with all sectors and stakeholders to make deeper changes to ensure stability of the service long term.
- 1.7. Within the budget for 2022/23 are management actions totalling just over £12 million.

1.8. Recommendation

Schools Forum is asked to note the DSG Deficit as set out in section 1 above.

2. DSG Settlement 2022/23

- 2.1. On the 17th December 2021 the Education and Skills Funding Agency (ESFA) announced the Dedicated Schools Grant allocations for 2022/23 and the extra allocations announced within the autumn 2021 Spending Review for schools and high needs.
- 2.2. Note that the final allocations will be adjusted through the year for recoupment academies and the updated Early Year's census. Individual maintained school budget allocations will be confirmed by 28th February 2022 following ratification by the ESFA; Academies will receive their notifications directly from the ESFA.

2.3. Recommendation

Schools Forum is asked to note the DSG 2022/23 announcement on 17 December 2021 as set out in section 2

3. Schools Block

- 3.1. The Schools Block allocation for 2022/23 is £485.03 million, which is additional funding of £26.35 million after including the Schools Supplementary Grant of just over £14 million and deducting the National Non-Domestic Rates (NNDR) £4.23 million top sliced amount.
- 3.2. As part of the consultation it was agreed that schools would see funding per the National Funding Formula (NFF) levels for 2022/23
 - Increase sparsity values maximum by £10,000 for primary, secondary and all-through schools.
 - 3% to Basic entitlement, free school meals at any time in the last 6 years (FSM6), IDACI, Low prior attainment, English as an additional language (EAL) and the lump sum.
 - 2% to the floor, the minimum per pupil levels and free school meals (FSM)
 - Introduce split site ceiling of £121,300 (equivalent to an additional lump sum)
 - Minimum Funding Guarantee (MFG) for 2022/23 is set at plus 2%.
- 3.3. After allocating the NFF it has meant that the balance can be allocated through the Additional Educational Needs (AEN) factors for Free School Meals (FSM), Free School Meals Ever6 (FSM Ever6) and Low Prior Attainment.
- 3.4. Since SFG met on 5th January 2022 and endorsed the funding allocation for the School Block there has been a change to the allocation in the Authority Proforma Tool.

Sparsity

- 3.5. As part of the consultation it was agreed that schools would see an increase to the sparsity values maximum by £10,000 for primary, secondary and all-through schools to reflect the latest National Funding Formula rates for 2022/23 and apply the Distance tapered threshold.
- 3.6. On receiving the latest Authority Proforma Tool, which includes the updated 2021 October census information, it is clear that we are unable assign all these factors within the sparsity allocations as there are additional schools eligible for sparsity that were not identified back in July using the indicative data.
- 3.7. The Operational Guidance states that Sparsity is an optional factor and that different values can be set in local funding formulae across all phases. The maximum permissible value is £100,000 (including the London fringe uplift)'

Proposal

- 3.8. To bring Devon to within its overall funding envelope and to ensure that it can be as close as is possible to the Sparsity National Funding Formula factors it is necessary to revert to the funding rates for 2021/22 with £45,000 for primary and £70,000 for secondary and all-through and not include the distance taper threshold for 2022/23.
- 3.9. This sees the 129 Devon schools eligible through sparsity having a reduction in their funding compared to that projected at autumn funding consultation. The range of reduction across the schools varies from £158 to £9,971, with 72 (54%) of these seeing a reduction of £8,000 to £9,971 due to this change in the sparsity factor calculations. 3 schools see an increase in funding of £19, £2,239 and £5,364. The breakdown of impact on individual schools are listed in Appendix A.

3.10. Recommendation

Schools Forum approve the change in the sparsity rates to that used in 2021/22 and calculation to ensure that Devon schools see the best funding position within the funding envelope available.

4. Central School Services Block

- 4.1. The Central Schools Service Block recognises the Ongoing Responsibilities of Education Services Grant (ESG), Admissions, Copyrights and Schools Forum along with Historic Commitments for Termination of Employment Costs.
- 4.2. In 2022/23 the DfE have reduced the Historic Commitments by a further 20%, however as with 2021/22 Devon has applied for a disapplication to remove this reduction to ensure that the Termination of Employment costs remain funded for the coming year of £873,000. This will be confirmed in the March DSG.

- 5.1. The High Needs Block continues to be under considerable budgetary pressure and after an additional £12.5 million, including the additional £3.6 million announced as part of the 2021 Spending review, the settlement allocation is £100.8 million.
- 5.2. The budget required to meet current HNB demand and agreed future growth with the service are summarised in Table 2 above.

Detailed explanation of pressures and planned actions

5.3. **Alternative Provision** (AP) includes Hospital Education. The budget for 2022/23 has seen an increase in the AP Medical Commissioning of £332,000 for 19 places and £66,000 diabetes funding. This is offset by a reduction in AP top-up funding of 10 places in the main commissioning contract of £126,000 and removal of grant income of £22,000.

The budget for 2022/23 for Hospital Education has seen additional funding received of £255,000 which will cover the costs for the Home School Tuition Service.

- 5.4. **Social Inclusion and Children in Care.** An increase to the budget of £66,000 is due to additional Pupil Premium funding being received relating to Children in Care.
- 5.5. **Maintained & Academy Special Schools.** Part of the SEN strategy is to invest in our maintained special schools to increase our own capacity to meet growing demand for placements in this type of provision, with an increase of £3.95 million. Overall, the budgeted places have increased to 1,610 in 2022/23 from 1,485 in 2021/22, with an average cost of £22,618. This includes 62 new places planned for April 2022 and 97 from September 2022.

The plan has identified management actions of £4.27 million which relates to Outreach support from special schools, SEN Support and prevention of more complex support requirements

increasing capacity, looking at an uplift in top up rates, but then explaining about MA savings in place which we should expect to see reduction NEW placements in SS, sort of contradicts the first part of expanding places but just need to try and explain it's not a cut to budget?

5.6. **Independent special schools.** There remains the overall funding gap within the HNB and there continues to be an increase in the numbers on roll in the Independent sector, seeing a rise of £9.6 million in the budget for 2022/23. This includes growth within the settlement of £3.7 million.

The budget has been set on 1,115 sole funded placements at an average cost of £46,400.

Built into the budget as part of the overall HNB management plan are management actions for 2022/23 of £6.9 million. These are identified as Outreach projects £960,000, core cost reduction in Independent settings and ceasing of 3-5 year placements £1.7 million, Expansion of special school provision £1.7 million for support centres £1.5 million and for prevention of more complex support requirements £1.1 million

- 5.7. **Recoupment.** Exports remain higher than imports for Devon and budget has been increased by £426,000 to meet the current level of funding required, based on the ESFA adjustment for Mainstream and Special Schools in both Maintained and Academy Sectors.
- 5.8. **Mainstream SEN.** Pre-16 Mainstream has seen a fall in the number of EHCPs from 2,857 to 2,593 for 2022/23, whilst Plus Packages have increased from 524 to 879 resulting in an £3 million increase overall. This is offset by savings of £436,000 in shortfall funding.

The Personal Budgets now has 91 pupils, a rise of 21 from 2021/22 at a cost of £524,000 and Tutoring has 105 pupils, a rise of 25 at a cost of £295,000. Increases in Multi-Sensory Impairment and SEN therapies has seen a further pressure of £179,000.

Management actions of £1.6 million has been built in for Outreach support to reduce need of EHCPs of £1.2 million, and reduced transition between phases of £383,000.

- 5.9. **Mainstream SEN FE**. Part of the strategy to control spend across the HNB is to grow the number of placements in FE colleges for 2022/23 the budget has been built for 785 students. An additional 78 direct funded placements have been identified at £470,000 plus 96 top up funded placements at £378,000.
- 5.10. **Support Centre Funding.** An increase to the provision of £374,000 is based on eight new support centres opening September 2022. This recognises that only three of the five identified to open this year have and the closure of Castle in December 2021.

6. Early Years Block

6.1. The formula allocates funding to local authorities for the existing 15-hour entitlement for all 3- and 4-year olds and the additional 15 hours for 3- and 4- year old children of eligible working parents.

The funding rates for both entitlements have seen a rise of 17p per hour, whilst the 2-year old funding has seen an additional 21p.

6.2. From April 2022 Devon will be funded at £4.61 per hour for 3- and 4-year olds (national average of £5.15) and £5.57 for 2-year olds (national average of £5.83).

7.1. Pupil Premium

The funding rates for Pupil Premium remain the same as for 2021/22. The illustrative budget is as per 2021/22. Allocations for 2022/23 are expected to be announced in the new year.

7.2. Universal Infant Free School Meals (UIFSM) Grant

The grant for universal infant free school meals (UIFSM) is at a meal rate of £2.34 for the 2022/23 academic year. We will be notified of further details by the ESFA in the new year. The illustrative budget is based on the latest available data for the 2021/22 academic year.

7.3. **PE & Sports Premium**

The illustrative budget is based on the latest available data for the 2021/22 academic year. We will be notified of further details by the ESFA in the new year.

7.4. Teachers Pay and Pension Grants

The majority of the Teachers Pay and Pension Grants is now included within Schools baselines. However, Early Years and Post-16 pupils remain as a separate grant. The illustrative budget is based on the latest available data for the 2021/22 academic year.

8. Carry Forward Decisions

Carry forward proposals will be taken to DEF meeting on 16th March, as by early March the outturn position will be far more certain than at present.

9. Recommendation

Schools Forum is asked to note the Schools Block, Central School Services Block, High Needs Block and Early Years Block as set out in section 3 to 8.
